Choose your Skilled Trades Training Route

OYAP Route (18 yrs +)

- apply to jobs in your chosen trade
- complete co-op course work placement in adult highschool & collect your letter of recognition or certificate from your school board

Employer Route

- apply to jobs in your chosen trade
- if required, request they sponsor you as an apprentice
- visit Employment Ontario Service provider for help finding a job

College Diploma Route

- apply to college trade programs
- Earn a college diploma in a trade of interest
- programs may include:
 - iob placement
- co-op options

Trade Union Route

- apply to unions and if required, request they sponsor you as an Apprentice in your trade
- unions may require different education standards than MLITSD

LBS Skills upgrading programs can help you at any point in your training

If you have chosen to register as an Apprentice:

- contact MLITSD office to update records if you are with a different employer than on your registered training agreement
- complete this step whether you are being hired by a new employer or by your placement employer.
- contact MLITSD to register as an apprentice when an employer has agreed to sponsor you
- you must provide proof of education already completed to count it towards vour apprenticeship
- apply to employers & request they sponsor you as an Apprentice in your trade

Exploring the trades & Educational Assessment Information

- Talk to tradespeople! Ask questions!
- Research Skilled Trades that interest you what education level do they require?
- A trade is classified as either compulsory or non-compulsory.
- <u>Compulsory trades</u> require that you be a registered apprentice, Provisional Certificate of Qualification holder or Certificate of Qualification holder to legally work in the trade.
- Non-compulsory trades do not require you to be a registered apprentice or certified journeyperson to legally work in the trade.

OYAP Route

- Complete your co-op course work placement in highschool or adult highschool
- If you signed a registered training agreement with MLITSD and your placement employer and you want to continue your apprenticeship beyond high school, collect your letter of recognition or certificate from your Co-op teacher
 - your letter or certificate must include:
 - the name of the trade,
 - name of the company and duration of the OYAP placement
 - number of hours completed
- Contact the local MLITSD office with your transcript and whether you are being
 hired or not by your placement employer to update their records. Register with an
 Employment Ontario Employment Service Provider. If hired by your placement
 employer, carry on with your training. If not hired, continue to next steps. You
 may need a copy of your transcript, depending on your chosen trade.

Employment Ontario Apprenticeship Offices

- If not hired, develop a resume highlighting your trade related experience and any other certifications to begin your job search. If you change sponsors after your high school coop placement, advise MLITSD of the change and sign a new training agreement with your current employer (sponsor)
- As you complete your work hours, review your Training Standards Log Book with your employer to sign off on completed skill sets and keep a record of all hours worked as an apprentice
- Complete any apprenticeship in-class training along with on-the-job training that is required for your apprenticeship.
- This process could take between 3-5 years to complete
- Once all requirements are met, prepare to write the Certificate of Qualification (C of Q) exam or Certification of Apprenticeship (C of A)

Employer Route

- Apply to Employers & request they sponsor you as an Apprentice, if required for your chosen skilled trade (they may require different education standards than MLITSD)

College Diploma Route

- Earn a college diploma in your trade of interest (programs may include job placement or co-op options)
- Apply to Employers & request they sponsor you as an Apprentice if required for your chosen skilled trade (they may require different education standards than MLITSD for insurance purposes)
- Visit a local Employment Ontario service provider, for assistance finding employment as an apprentice:
